1- Acceptable Identity Documents are: Breed Registration, NF Passports, Import Health Certificates & Previous ID documents registered with any National Federation. 2- If the horse is below four years of age and born in the UAE, passport copies of both the sire and the dam have to be submitted. 3- In order to fill in the "Markings & Descriptions Page" and the "Equine Influenza Vaccination" details, contact a veterinarian approved by the UAE Equestrian and Racing Federation. 4- On receipt of the application, passport will be issued within 7 working days. 5- TOS Transfer of ownership requires the following: - New owner passport copy for the imported horses a copy of import permit / sale deal. 6- If the horse is 4 yrs of age and doesn't have any previous identity documents it is mandatory that the horse is micro chipped. 7- For the TOS, form duly signed by the current owner and the new owner should be submitted.
