- Horses must be presented with an approved *National or FEI* passport
- All the horses have to be micro-chipped
- The electronic heart rate monitor and display system shall be used to determine the heart rate of horses as per set protocol.
- At the Pre-ride Inspection please ensure that the horse is sufficiently warmed up before inspection. Any horse which will not permit examination, or which is dangerous to the examiners shall be eliminated.
- Riders must present their photo ID when they come for weighing.
- Pre-ride Briefing will be held at the end of the First Inspection.
- Riders must wear hard type riding helmets with chin strap and shoes with heels unless they use caged (boxed) or equestrian stirrups. The horse's head must have freedom of movement.
- Whips, spurs, draw (running) reins/French reins & long reins are not permitted. Any type of rein that might unduly restrict the free movement of the head of the Horse, including draw (running) reins/French reins is prohibited.
- Horse tack must be in a safe condition and correctly fitted to avoid the risk of pain or injury to the Horse.**
- Ear plugs are strictly prohibited.**
- Metal chain nosebands are forbidden. A leather or plastic noseband is permitted but must be adjusted to allow at least two fingers under the noseband on the front of the nose.**
- Private cars are not permitted in any forestry area. Crew members & drivers please note that any act amounting to intimidation of a competition horse

- will be severely dealt with. Giving water or assistance from inside a car is forbidden
- No crewing in the entrances or inside the vet gate. Crew is not permitted to wait for the horse at the Time Window.
 - Crewing outside the designated crew points is prohibited and will result in Disqualification
 - Only one crew member is permitted with the horse in the inspection area.** Any act of deliberate delay in presenting the horse for examination will be severely dealt with.
 - Two crew members are permitted for each horse in the cooling area.**
 - Dyes including henna may not be used on the Horse at any time on the Field of Play as it may obstruct the veterinary inspection and identification of the Horse.**
 - Pulse Re-Inspection requires a new Vet-In Time. The exit of the horse from the Vet Inspection Area must be recorded at the "Way Out" window before a new Vet-In Time can be given.
 - Recovery Inspections shall be less than 15 minutes before departure.
 - Horses not presented to an official Ride Veterinarian after removal from active competition will automatically lead to a 60 days' rest period for that horse.
 - For 5 horses 1 trainer car and crew car only.
 - For less than 5 horses 1 crew car only
 - Only cars with stickers will be allowed in the tracks.
 - No cars allowed in the Natural trails
 - Water point every 5 km and crewing not allowed between these water points.
 - Any kind of assistance strictly forbidden within 5 kms from arrival gate and the finish line.
