- Horses must be presented with an approved National or FEI passport.
- 2. All the horses have to be micro-chipped.
- The electronic heart rate monitor and display system shall be used to determine the heart rate of horses as per set protocol.
- 4. At the Pre-ride Inspection please ensure that the horse is sufficiently warmed up before inspection. Any horse which will not permit examination, or which is dangerous to the examiners shall be eliminated.
- 5. Riders must present their photo ID when they come for weighing.
- 6. Pre-ride Briefing will be held at the end of the First Inspection.
- Riders must wear hard type riding helmets with chin strap and shoes with heels unless they use caged (boxed) or equestrian stirrups. The horse's head must have freedom of movement
- Whips, spurs, draw (running) reins/French reins & long reins are not permitted. Any type
 of rein that might unduly restrict the free movement of the head of the Horse, including draw
 (running) reins/French reins is prohibited.
- Horse tack must be in a safe condition and correctly fitted to avoid the risk of pain or injury to the Horse.
- 10. Ear plugs are strictly prohibited.
- Metal chain nosebands are forbidden. A leather or plastic noseband is permitted but must be adjusted to allow at least two fingers under the noseband on the front of the nose.
- 12. Private cars are not permitted in any forestry area. Crew members & drivers please note that any act amounting to intimidation of a competition horse will be severely dealt with. Giving water or assistance from inside a car is forbidden.
- No crewing in the entrances or inside the vet gate. Crew is not permitted to wait for the horse at the Time Window.

- **14.** Crewing outside the designated crew points is prohibited and will result in Disqualification.
- Only one crew member is permitted with the horse in the inspection area. Any act
 of deliberate delay in presenting the horse for examination will be severely dealt with.
- 16. Two crew members are permitted for each horse in the cooling area.
- Dyes including henna may not be used on the Horse at any time on the Field of Play as it may obstruct the veterinary inspection and identification of the Horse.
- 18. Pulse Re-Inspection requires a new Vet-In Time. The exit of the horse from the Vet Inspection Area must be recorded at the "Way Out" window before a new Vet-In Time can be given.
- 19. Recovery Inspections shall be less than 15 minutes before departure.
- Horses not presented to an official Ride Veterinarian after removal from active competition will automatically lead to a 60 days' rest period for that horse.
- 21. For 5 horses 1 trainer car and crew car only.
- 22. For less than 5 horses 1 crew car only
- Only cars with stickers will be allowed in the tracks.
- 24. No cars allowed in the Natural trails.
- 25. Water point every 5 km and crewing not allowed between these water points.
- 26. Any kind of assistance strictly forbidden within 5 kms from arrival gate and the finish line.
- 27. Green pass on Al Hosn app with PCR test validity not exceeding 4 days.
