- 1. Horses must be presented with a National or an FEI passport, whichever applicable.
- 2. All the horses have to be micro-chipped.
- 3. Horses competing at FEI events have to fulfill the horse health requirement via the FEI Horse App .
- 4. The electronic heart rate monitor and display system shall be used to determine the heart rate of horses as per set protocol.
- 5. At the Pre-ride Inspection please ensure that the horse is sufficiently warmed up before inspection. Any horse which will not permit examination, or which is dangerous to the examiners shall be eliminated.
- 6. Riders must present their photo ID when they come for weighing.
- 7. Pre-ride Briefing will be held at the end of the First Inspection.
- 8. Riders must wear hard type riding helmets with chin strap and shoes with heels unless they use caged (boxed) or equestrian stirrups.
- 9. Whips, spurs, French reins & long reins are not permitted. The horse's head must have freedom of movement.
- 10. Horse tack must be in a safe condition and correctly fitted to avoid the risk of pain or injury to the Horse.
- 11. Any shank (lever arm) on any bit may not exceed 10 cm.
- 12. Ear plugs are strictly prohibited.
- 13. Metal chain nosebands are forbidden. A leather or plastic noseband is permitted but must be adjusted to allow at least two fingers under the noseband on the front of the nose.
- 14. Private cars are not permitted in any forestry area. Crew members & drivers please note that any act amounting to intimidation of a competition horse will be severely dealt with. Giving water or assistance from inside a car is forbidden.
- 15. No crewing in the entrances or inside the vet gate. Crew is not permitted to wait for the horse at the Time Window. Crewing outside the designated crew points is prohibited and will result in Disqualification.
- 16. Only two crew members are permitted with the horse in the inspection area (Vetting Area). Any act of deliberate delay in presenting the horse for examination will be severely dealt with.
- 17. Four crew members are permitted for each horse in the cooling area & crewing points.
- 18. Pulse Re-Inspection requires a new Vet-In Time. The exit of the horse from the Vet Inspection Area must be recorded at the "Way Out" window before a new Vet-In Time can be given.

- 19. Recovery Inspections shall be less than 15 minutes before departure.
- 20. Horses not presented to an official Ride Veterinarian after removal from active competition will automatically lead to Disqualification for "Horse Not Presented",60 days' rest period for that horse, Yellow Warning Card for Athlete and Trainer, 100 Penalty points for Athlete and Trainer.

- 21. Should an Athlete wish to retire their Horse at the end of a Phase, the Horse must be presented to the Vetting Area and pass all required Inspections. The maximum time a Horse has for Retirement after completing a Phase is its hold time plus 15 minutes.
- 22. At the first Vet Gate and onwards, except for the Final Inspection, all Horses entering with more than 10 minutes recovery time must pass a compulsory re-inspection.
- 23. A curb chain may never be so tightly fixed that it risks causing (or causes) irritation to the skin. It must be observed to have laxity when the reigns are loose.
- 24. Failure to comply with the time limits for presentation of the Horse to the Vetting Area will result in Disqualification for Late Presentation.
- 25. No Combination may start later than 15 minutes after the official start time of each Phase.
- 26. If an Athlete is weighed during a Competition and is under the minimum weight by less than 1kg, the Athlete will be permitted to continue except for the final loop. If during the same Competition the Athlete is weighed again and is under the minimum weight (by any amount), the Combination will be Disqualified.
- 27. For 5 horses 1 trainer car and crew car only. For less than 5 horses 1 crew car only
- 28. Only authorised trainer with a valid trainer ID and wearing a trainers vest is allowed in the event. Any unauthorised person is not allowed to wear the trainers vest during the event.
- 29. Only authorised team Vet with a valid Team Vet ID and wearing a Team Vet vest is allowed in the event. Any unauthorised vet is not allowed to wear the Team Vet vest during the event.
- 30. Only cars with stickers will be allowed in the tracks.
- 31. No cars allowed in the loops. There will be separate track only for cars.
- 32. Cars are only allowed from crew point to crew point.
- 33. Water point every 2.5 km and crewing not allowed between these water points.
- 34. Any kind of assistance strictly forbidden within 2 kms from arrival gate and the finish line.










المادة 825 المعدات Art. 825 - Tack and Equipment

825.1 شروط المعدات : يجب أن تكـون عـدة الركـوب فـي حالـة آمنـة ومركبـة بشـكل صحيح لتجنب ايـة الأم أو إصابـة للحصـان. قـد يطلـب الرسـميون إزالـة أو تغييـر أي مـن المعـدات غيـر المناسبـة. يمكـن اعتبـار استخدام أي مـن المعـدات غيـر المناسبة التـي تتسبب فـى (أو تسبب) ألمًا أو إصابـة للحصان إساءة معاملـة للحصان

825.2.5 لا يجوز أن يتجاوز أي مقبض (ذراع الدعامة) على أي شكيمة 10 سم. (انظر المثال أدناه)

825.1 Tack condition: Horse tack must be in a safe condition and correctly fitted to avoid the risk of pain or injury to the Horse. Officials may require any ill-fitting tack/equipment to be removed or altered. The use of any ill-fitting equipment that risks causing (or causes) pain or injury to the Horse may be considered as Horse Abuse

825.2.5 Any shank (lever arm) on any bit may not exceed 10 cm. (See the example below)








Any person found in possession of Controlled Medication Substances, syringes, needles, or similar equipment within the Field of play or administering unauthorized treatment will be reported to the Ground Jury and will be sanctioned:

- 1. Disqualification.
- 2. Yellow Card.
- 3. The incident will be reported to the UAE Equestrian & Racing Federation Disciplinary Committee.
